

Roar and Explore Incentive Terms & Conditions

1. Eligibility

Open to Dicker Data Australian reseller partners with a valid trading account in good standing. Must register for the incentive via the official campaign landing page.

Only sales made between 8 May 2025 and 31 October 2025 will be considered.

Partners must meet the minimum revenue thresholds to be eligible:

- HPE HIT Trailblazer: \$250,000 AUD minimum threshold.
- HPE HIT categories except Trailblazer: \$500,000 AUD minimum threshold.
- Aruba Networking category: \$500,000 AUD minimum threshold.

2. Qualifying Sales
